Tuberculosis (TB) screening is required for incoming international students (non-permanent residents) that were born in, hold citizenship or have resided in one of the following countries or territories for more than three months:

Texas A&M University Health Services policy

- T-Spot or QuantiFERON-TB Gold testing is required. TB skin testing will not be accepted as TB screening.
- TB blood testing and chest x-rays (if required) must be done within six months prior to the start of the semester the student is choosing to enroll.
- Students with a prior BCG immunization still require tuberculosis testing.
- Students with positive TB blood test results will be evaluated at University Health Services or local health department.
